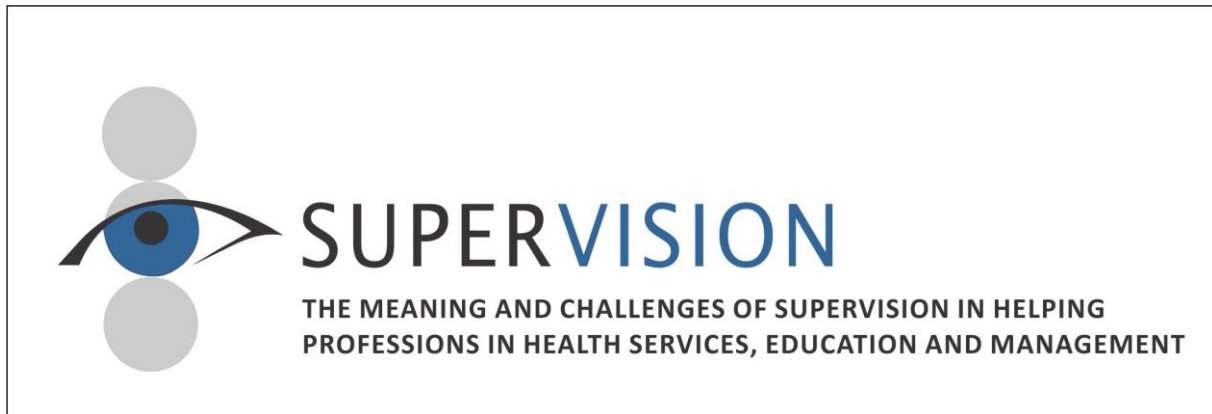

**Professionals in helping professions often feel pressure in their working environments**, be it when working with people with special learning and emotional needs, with people suffering emotional distress due to traumatizing experiences, depression, burn-out, pressures from their work-place, due to mental disease, due to difficult financial circumstances, in times following family disruption, suffering from physical illness or having difficulties in adjusting to society.

In all these roles, one is frequently obliged to seek a balance between the stress of the work with clients, time-limits and increasingly frequent and faster modifications in organisation and working environment.

You may only be able to provide efficient performance and quality work to clients in your demanding professions if sufficient support is offered to you at your workplace which includes quality supervision.

**In order to present what is supervision and what its role and meaning is in helping professions, the 2018 annual event has been planned to address this topic with lecturers from the country and abroad.**

**Challenges of supervision shall be openly discussed and different approaches presented, together with various techniques nowadays used in the process of supervision.**

**Lectures** are complemented by **workshops** planned to demonstrate practical approaches of local and foreign professionals. Challenges of supervision shall be discussed in a **roundtable**. **Group supervision** shall be offered to participants. A session will be dedicated to presentations of **new books and publications** in the domain.

Welcome to colleagues from other therapeutic orientations, psychologists, psychiatrists, physicians in family medicine and paediatrics, nurses and other health workers, social pedagogists, social workers, occupational therapists, teachers, professionals in management and »human resource« departments, and any professionals working in situations where supervision may be needed even if not (yet) available.

Regardless of the previous exposure to supervision, the event is welcoming beginners, those with experience or already active in a tutoring or supervising role.

The official languages are Slovene and English. There will be no formal translation of lectures and workshops. All the slides presented by the foreign guests shall be translated into Slovene. For those participants needing linguistic support, informal translation to Slovene (sitting in a group around a linguistically more competent person) shall be provided.
